

DAMTP:

 Giulio Del Zanna has obtained a grant from the Royal Society to start a new research collaboration with a group at the Physical Research Laboratory (PRL), Ahmedabad, led by Professor Santosh Vadawale. PRL is one of the main research institutes in India and is involved in all Indian space science missions. The project title is, 'X-ray spectroscopy of solar flares with Chandrayaan-2 XSM'. Professor Vadawale is the principle investigator of the Solar X-ray Monitor (XSM) aboard the upcoming second Indian moon mission -Chandrayaan-2, to be launched this year. XSM is the only spectrometer in the near future that is designed to measure continuously the X-ray emission from the Sun.

Cecil King Travel Scholarship 2018 EARLY CAREER RESEARCHERS

The London Mathematical Society annually awards a £5,000 Cecil King Travel Scholarship in Mathematics, to a young mathematician of outstanding promise. The Scholarship is to support a period of study or research abroad, typically for a period of three months, in any area of mathematics. STEP Support Programme events for Cambridge offer-holders UPDATE

To supplement and extend the free online support available to applicants via the online <u>STEP Support</u> <u>Programme</u> every UK state-school student holding a conditional Cambridge offer based on STEP II and III (i.e. Mathematics and a small number of Computer Science offer-holders) was invited to attend an optional STEP preparation day event in March. 202 of the 290 eligible students sent invitations by the Cambridge Admissions Office took up the opportunity to attend. Three separate days were planned, and two have already taken place, and the final day will take place on Wednesday 14th March. These days have included talks about STEP and exam preparation by Stephen Siklos and Claire Metcalfe (STEP Support Programme/NRICH), as well as STEP workshops led by NRICH staff Ems Lord, Alison Kiddle, Becky Warren and Claire Metcalfe. The afternoon workshops have been supported by current undergraduate and postgraduate mentors, and have included a panel session and Q&A with current Cambridge students. The feedback from the first two days has been enormously positive (both about the events themselves and the online STEP materials). The organisers are grateful to Churchill College for support in hosting these days; to James Munro, Zain Patel, Jemma Fendley, Matthew Jones and Eve Pound who talked about their own experiences of STEP; and for the generous assistance from the student mentors and everyone else involved.


